## 2015 Gold Coast Airport Marathon

## **Suncorp Bank Fundraising Incentive Terms and Conditions**

  - c. actively raise funds through their fundraising account for a charity of their choice securing a minimum of Fifty Dollars (\$50.00) worth of donations ("Eligible Participants")

- 7. Participants under the age of 18 must obtain the prior permission of a parent or guardian over the age of 18 to enter.
